On 12/10/2010, I was on uniformed patrol in my marked patrol car for the Cape Coral Police Department.

I was southbound on Northeast 13th Avenue approaching Northeast 9th Street. I saw a green 4-door Mitsubishi on Northeast 9th Street at the stop sign for Northeast 13th Avenue. The green Mitsubishi was on the east side of the intersection, and pulled out in front of me heading westbound on Northeast 9th Street.

I had to slam on my brakes to not "T-bone" the green Mitsubishi in the intersection. I turned westbound on Northeast 9th Street where I conducted a traffic stop on the green Mitsubishi at the 1000-block of Northeast 9th Street.

I spoke with the driver, later identified as Alia Alexander, and informed her of the traffic infraction. Mrs. Alexander stated she was on the phone not paying attention and did not know the intersection was not a 4-way stop. I requested Mrs. Alexander to provide her Driver License, proof of registration and insurance.

Officer Cantrell arrived on scene as back up due to foot traffic around my traffic stop.

I had Mrs. Alexander come back to my patrol car where I issued her Warning Citation 10W03726, for failure to yield to right of way. I gave back Mrs. Alexander all of her paperwork and told she was free to go.

Before Mrs. Alexander got to her vehicle, I asked her if it was ok to search her vehicle. Mrs. Alexander stated I could search her vehicle and I requested for her to stay with Officer Cantrell by my patrol car.

I searched the green Mitsubishi and found a multi-colored glass smoking pipe in the driver side door storage compartment.

I seized the smoking pipe and showed it to Mrs. Alexander. I read Mrs. Alexander her Miranda Rights from a prepared CCPD Field Card to which she stated "Yes" to understanding her rights.

Mrs. Alexander stated the smoking pipe was given to her as a present from an old boyfriend. Mrs. Alexander knew she should not have been transporting it in the vehicle and the pipe was hers. Mrs. Alexander declined to provide a sworn written statement.


Officer Cantrell went for a second look in the vehicle but no other contraband was found. I issued and explained to Mrs. Alexander the Notice To Appear 175298 for F.S.S. 893.147 (1), Drug Paraphernalia – Equipment Possess.

Officer Angela Fleming asked Mrs. Alexander if it was ok to search her before she left to which Mrs. Alexander agreed. Nothing was discovered on Mrs. Alexander's person and she left in apparent good health.

I later transported the smoking pipe and submitted it into CCPD Evidence.
